Combatting BDS Act

In Congress, we must support and enact anti-BDS legislation such as the Combatting BDS Act of 2017. This legislation enables state and local governments to restrict business dealings with any groups that target Israel through the use of BDS tactics. Empowering our states to seek out and deny these bad actors will help support Israel and safeguard against any destabilizing efforts. I would also support the Israel Anti-Boycott act, which defends U.S. companies from being forced to participate in anti-Israel boycotts from international organizations like the EU or UN. BDS is anti-Semitic and seeks to economically isolate Israel. The U.S. must stand with Israel against BDS.

The U.S. contributes more than 20% of the permanent budget to the United Nations. As such we hold tremendous influence and should use that influence to combat anti-Israel bias within the international community. The Palestinians continue to use their diplomatic status to make false accusations of war crimes and garner support for biased boycotts. The U.S. must always work to make sure these arguments are exposed as lies and stand strong in defending Israel within the international community.

Peace in the Middle East
